INFORMATION NOTICE ON THE PROCESSING OF VISITORS' PERSONAL DATA pursuant to Article 13 of Regulation (EU) No. 2016/679

Dear Visitor,

in accordance with the Regulation on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (Regulation (EU) of 27 April 2016, No. 2016/679 – GDPR), we hereby inform you that ABE Elettronica Srl processes your personal data for the purposes described below, in compliance with the applicable personal data protection legislation.

Data Controller

Categories of personal data processed

The personal data processed by ABE Elettronica Srl are: first name and last name, company affiliation.

Purpose of the processing

The Data Controller processes the data provided for activities strictly related to access to and exit from the company premises, for security reasons.

Legal basis for processing

The legal basis for processing is Article 6(1)(c) of the GDPR.

Nature of data provision

The provision of data is mandatory as required by law. Failure to provide such data or any objection to their processing may result in the inability to access the company's premises.

Methods of processing

Your personal data may be processed in paper form and by electronic means, in compliance with all appropriate measures to ensure their security and confidentiality. Access to the data is restricted to authorized personnel who have been duly appointed as Authorized Persons or Data Processors. Access is permitted only for the time strictly necessary to carry out the processing and exclusively for the purposes indicated above. Appropriate security measures are adopted to minimize the risk of destruction or loss, including accidental loss, unauthorized access, or processing that is unlawful or not consistent with the stated purposes.

Communication of data to third parties

Your personal data will not be disclosed.

Data retention period

Your personal data will be processed and stored in a form that allows identification for a period no longer than necessary to achieve the purposes for which they were collected

and, in any case, for no longer than one month.

Transfer and storage of data abroad

The Data Controller does not transfer personal data outside the territory of the European Union.

Data subject's rights

Pursuant to Articles 15 et seq. of the GDPR, where applicable, you may exercise the following rights:

- Right of access (Art. 15 GDPR): the right to obtain access to your personal data and to lodge a complaint with the supervisory authority;
- Right to rectification (Art. 16 GDPR): the right to obtain from the Data Controller the rectification of inaccurate personal data concerning you;
- Right to erasure (right to be forgotten) (Art. 17 GDPR): the right to obtain the erasure of personal data concerning you without undue delay;
- Right to restriction of processing (Art. 18 GDPR): the right to obtain a restriction of processing;
- Right to data portability (Art. 20 GDPR): the right to receive the personal data concerning you, provided to the Data Controller, in a structured, commonly used and machine-readable format, and to request their transmission to another data controller, where technically feasible.

The Data Controller shall notify each recipient to whom personal data have been disclosed of any rectification, erasure or restriction of processing carried out in accordance with Articles 16, 17 and 18 (notification obligation pursuant to Article 19 GDPR).

Furthermore, pursuant to Article 7(3) of the Regulation, you have the right to withdraw your consent at any time, without affecting the lawfulness of processing based on consent before its withdrawal.

Right to lodge a complaint

If you believe that the processing of your personal data infringes the Regulation, you have the right to lodge a complaint with the Supervisory Authority, following the procedures and instructions published on the official website of the Authority (www.garanteprivacy.it), as provided for by Article 77 of the Regulation.

Without prejudice to any other administrative or extrajudicial remedy available, you also have the right to an effective judicial remedy if you consider that your rights under the GDPR have been infringed as a result of the processing (Article 79 GDPR).

Exercise of rights

The exercise of rights is not subject to any formal requirement and is free of charge.
